EXERCISE OF LISTED OPTIONS

Catalyst Metals Limited (Company) is pleased to advise that a further 769,858 listed options (Options) have been exercised at 50 cents per Option prior to the expiry of the Options on 30 June 2018.

A notice of the pending expiry of the Options was sent to all option holders on 28 May 2018.

The shortfall from the exercise of the Options amounted to 318,528 Options (Shortfall Options). Notice of the shortfall is being given to ASX-listed St Barbara Limited (St Barbara) pursuant to an underwriting agreement dated 7 December 2017. Under the terms of the underwriting agreement, St Barbara has agreed to exercise the Shortfall Options in shares. No fee or commission is payable by the Company for the underwriting of the Options.

The exercise of these Options and the Shortfall Options will increase the Company's cash reserves by a further \$0.54 million.

Please find enclosed an Appendix 3B for the allotment of 769,858 ordinary fully paid shares in the Company following the exercise of Options.
